Avery said that she would be competing for the title of "Miss Alabama Teen" March 7-9. She plans to share a little of her initiative, called Shine-a-Lot, which focuses on mental health and adolescents. She explained that mental health is a vital part of our well-being, but that it is often overlooked or stigmatized. Related to this cause. Avery is raising funds for two organizations: The American Heart Association, which recognizes the connection between physical and mental health; and Brooks Place, which provides restoration of hope and resilience in the lives of young kids who have been abused and need help the most. She continued, saying, "Mental Health is a collective community responsibility, and together, we can create a supportive environment where one feels valued and understood. By raising awareness and funds for the American Heart Association and Brook's Place, child advocacy center, we're taking meaningful steps towards a healthier, more compassionate community."

At the conclusion of her talk, Lion Charlie Childers recommended that we "pass the hat" for an account for Avery who still has to raise money within the community to support the pageant and her initiative. This we did. Lion Chris Brooks also presented her with a check to fully pay for an ad in the Miss Alabama event brochure for the Cullman Lions; this is part of the qualification process that must be completed on her part to qualify for the Pageant. We wish the best for Avery in the coming competition. We should be proud that we are able to bring forward such talented young women to represent our County and City.
